Main Trustee :- Shastri Balkrushnadasji Gurushastri Krushnajivandasji will be as the main trustee i.e. President i.e. Manager of this Trust

Aims of this Trust :- (1) To help the children of poor family. with medicines, clothes, books, fee, grains etc.

(2) To help saints Brahmins and devotees.

(3) To help the victims of sudden calamities such as excessive rainfall, droughts.

(4) To attend seminar of youth-children for maintaining and propoganding Indian culture.

(5) To help the country at the time of fights, attacks etc. on the country.

- Officers :- There will be a president, Vice-president and 3 trustees together total five trustees. The President himself will do the work of the manager. And he will have all the powers of the Trust.
- Way to appoint the officers :- All the officers of the trust will be considered permanent. If any one expires in the Officers or gives resignation, that time the remaining Trustees can appoint a qualified person on his place by majority.
- Qualification of the officers :- The officers should be of calm nature, cultured, well-educated and experienced. And should be of at least 25 years. The officers should not be insolvent and should not be punished in criminal offense from the criminal court.

Time period :-

In any circumstances if question arises to close the activities of this trust or if this Trust does not work in any circumstances then all the properties and the powers will be handed to the *Gadi* *of Shri Laxminarayan Dev established by Shri Swaminarayan, Vadtal.

Balance :-

To open an account in the bank in the name of the trust and the trust will have the right to withdraw, deposit money on behalf of the trust. The president should not keep more than Rs. 500 on behalf of the trust.
